CALL TO ORDER: President Marjean Sutherland at 10:43 a.m.

FINANCIAL REPORT/CONSIDERATION OF 2020 BUDGET:

Betsy Wiegel and Marjean Sutherland reported that we are running in the negative. A \$5,000 donation was announced to council in December but payment will be received for 2020 financial report.

President Marjean Sutherland shared that the council is looking seriously at ideas on how to cut back costs which included: removing dumpster and going to curb side pick up which we pay to City regardless if we use it or not. Also looking at ways to reduce paper, postage, offering envelopes and using e-mail to those members that are willing to do so. A survey will be sent on church members prefences. It was also mentioned that the Pastor, Secretary and Organist have not recieved a raise in 3 years and thanked them for their support.

Marjean asked if anyone had any questions about the Financial Report: A discussion was held on the fee's to the Church for Weddings and Funerals that was introduced in 2019. It will be discussed at a future council meeting taking into consideration comments made by members.

Motion to accept budget was made by Matt Ubersox and second by Harold Douglas. Motion carried.

BENEVOLENT FUND: Betsy Wiegel thanked the Stewardship Committee for a good job as donations were received above our goal.

AUDITORS REPORT: No discussion

OLD BUSINESS: No discussion

NEW BUSINESS: By law changes-- Addition to Article X

- 7. **Stewardship Committee:** The Stewardship Committee shall consist of at least four (4) members but not more than five (5). The members of the Committee shall be appointed by the Church Council with no term limit. It shall be the responsibility of the Committee to promote the treasure of stewardship by providing related education to church members and encouraging them to share their God-given gifts of time, talent, and treasures. The Committee shall promote fellowship and friendship within the Congregation to keep members active with all generations of families worshiping together.
- 8. Evangelism, Fellowship and Growth Committee (EF&G): The EF&G Committee shall consist of no more than seven (7) members. The members of this Committee shall be appointed by the Church Council with no term limit. The purpose of the EF&G Committee is to encourage the spiritual fellowship of the Church by joining together to build friendships which are strengthened through fellowship for the purpose of working for God. The committee will strive to provide a nurturing and social environment for members and visitors by planning and coordinating Church social and liturgical events. They will also welcome new members, assist the Secretary with maintaining a church directory, and maintain the history of the Church.
- 9. Other Committees: Other Committees may be appointed on an ad hoc basis as deemed necessary and appropriate by the Church Council. In any such case, the membership and task of the committee along with its duration of existence shall be clearly stated by the Church Council.

Motion made by Scott Glendenning and second by Dave Sutherland. Motion Carried.

NOMINATING COMMITTEE: Consisting of JoAnn Geissbuhler, Janice Ruf, Connie Ubersox and Pastor Barbara Brakey have confirmed that Fritz Hirsbrunner and Sheila Siegler will accept nomination to church council and Randy Ubersox, Judy Huntington, and Jean Stauffacher will accept a 2nd term for council.

Marjean Sutherland and Betsy Wiegel have served their terms on Council. Marjean Sutherland agreed to serve on the Endowment Fund Committee replacing Spider Fromader who served his term.

President Marjean Sutherland asked for any further nominations: None were recieved.

Motion to accept nominations by Paul Badertscher and second by Harold Douglas. Motion carried.

Other Matters: Thank you to Betsy Wiegel for serving 8 years on Council as she took over for someone who could not fulfill their term and also for doing such a tremendous job as treasurer. Randy Loken thanked Marjean Sutherland for her time and dedication as Church Council President and her exemplary job.

2020 Annual Report of the Conference Minister

"The lessons of history remind us that the Church at large survives largely because churches endlessly reinvent themselves as they resist pressures that would see them vanish with the morning mist."

This quote from Professors Andrew Village and Leslie J. Francis of York St. John University, sums up the Epiphany hope we cling to for the future of the Church in such uncertain times. We enter 2021 with determined endurance, recognizing the toll COVID-19 will continue to take until vaccinations are widely available. Yet, we can see the light at the end of this tragic tunnel, and this prompts a spirit of resilience!

The mission of the Wisconsin Conference of the United Church of Christ – to connect, support, and resource local congregations and leaders – was vital and essential in 2020. Conference staff dedicated considerable time and energy addressing the pandemic. With collaborative support from the Wisconsin Council of Churches, we provided guidelines and protocols as the spread of COVID-19 forced rapid changes in congregational life. Pastors and lay leaders adapted to virtual technology instantaneously, developing creative ways of providing socially distanced worship and pastoral care. While many of us suffer Zoom fatigue, we nevertheless give thanks for the church-saving grace of digital connections.

Through the generosity of many to the COVID Emergency Response Fund, the Wisconsin Conference was able to offer technology, relief and continuing education grants to over 20% of our congregations. We also curated and created various worship resources in order to support weary pastors in need of a Sunday respite. At the turn of the New Year, three things seem evident:

- 1) Many congregations have managed to remain steady with a faithful and fruitful witness to the Gospel despite the necessary changes and the social isolation, though congregations that entered 2020 in fragile states continue to struggle,
- 2) there remains deep anxiety and concern as to the recovery and renewal of church life, particularly the unknowns of future in-person worship attendance and ongoing strength of stewardship, and
- 3) nearly all congregations are exploring ways to capture the technology learnings and incorporate hybrid models of worship in a post-COVID era.

Perhaps the hardest hit ministry among us was United Church Camps Incorporated (UCCI). This beloved bedrock ministry of our Conference launched a remarkably successful Matching Gift Campaign called Keep the Fires Burning in order to stay funded through the end of the pandemic. The partnership between UCCI and the Wisconsin Conference is strong, and we have every intention of returning to a thriving outdoor camping and retreat ministry. Thanks to all who have so generously responded!

Annual Meeting 2020 took the form of a very abbreviated Zoom Meeting, the highlight of which was endorsing and committing to a 10-year effort to address climate change. The Kairos Call to Action is a 10-step earth-saving program designed for church communities and family households. The Conference Creation Care Team has done extraordinary work in launching this initiative, and has set a high goal of engaging half our congregations in this commitment.

In addition to Creation Care, our Wider Church justice initiatives continue as a collective resource to all congregations, empowered by passionate volunteers who help push along these ongoing and important working groups: Racial Justice, Immigration/Refugees Advocacy, LGBTQIA Plus, Break the Silence, Bethlehem Stars, Interfaith Peace, Human Trafficking, and Jail/Prison ministries.

I want to highlight three exciting and evolving Conference ministries:

The Supportive Ministries Team provides resources and tools, wisdom and insight, for these challenging times. Their periodic publication Tending the Soul of the Beloved Community is excellent! This team of retired pastors and lay people seek to highlight the important ministries that provide such rich support: Communities of Practice, Coaching/Strategic Conversations, Conflict Transformation, Church Vitality resources, Appreciative Inquiry facilitation, etc.

The Damascus Project now encompasses Faith Foundations (Lay Academy) and courses for the purpose of clergy continuing education, lay person biblical and theological development and offerings that will train those seeking an alternative path to authorized ministry. This joint project with the Minnesota Conference is gaining traction and attracting wide participation!

The Development and Stewardship initiatives, led by the Rev. Andrew Warner, provide valuable education for annual stewardship, capital campaigns, legacy giving, and investment financial management through the Wisconsin Foundation of the UCC (provided by the Pension Boards' Generation Company).

Finally, we experienced some changes in our Conference Staff during 2020. Vicki Graff, longtime Director of Finance, retired this past summer. Tracy Hauge now serves as our only in-house Finance staff person, managing all deposits and expenses and communicating daily with our accounting firm, a non-profit in Escanaba, Michigan, called Community Foundation of the Upper Peninsula. This outsourcing of our accounting brings significant cost savings yet continues to allow us to provide personal service to our congregations. Additionally, in anticipation of the retirement of Deb Simon this coming summer, we have hired a very gifted part-time Annual Meeting Event Planner, Katie Komassa. I must say, we are so very blessed with an excellent, dedicated and gladhearted staff!

Siblings in Christ, keep the faith, and remember the words of Paul:

"And not only that, but we also boast in our sufferings, knowing that suffering produces endurance, and endurance produces character, and character produces hope, and hope does not disappoint us, because God's love has been poured into our hearts through the Holy Spirit that has been given to us." Romans 5:3-5

Given that I was with you for only the final month of 2020, I'm not really in a position to give much of a "report". Regarding last year, I will say that landing at a new church on the first Sunday of Advent (New Years Day on the Church calendar) in the middle a global pandemic and introducing the congregation to worship by Zoom was as challenging as it was exciting. You are to be commended, in my opinion, for your flexibility and your willingness to step into a new way of being church in these unsettling times.

So that's my "re-port" for 2020.

What follows then, is a look into the year ahead. Here's my "pro-port" (I just made that word up) looking ahead to 2021.

It seems to me there are two important tasks before the congregation for the coming year; and maybe occupying us a bit beyond 2021. The first, of course, is to begin and follow through on the process of searching for and calling a new pastor to serve the congregation. The "calling a new pastor" will probably be the easiest part of that. What comes before the call is the work of discerning who this congregation being called to be and what you are being given to do in our fast changing 21st century—where church and culture are drifting further apart and fewer people are drawn to what we offer with each passing year.

Maneuvering this new religious landscape will not be easy. But if we approach this task in faith and hope, trusting the ever-present Spirit of God to be our guide, I can promise you the work will be energizing and life giving, both for you and for those who will benefit from your effort. So when you are invited by the Church Council or search committee to help out, count yourself fortunate and step into the work to be done.

The second and more immediate task at hand is to continue being the church in the middle of this seemingly unending pandemic. Being the church in our current setting means being with and for each other in ways that may be very different from what we are accustomed to. Worshipping together on Zoom and Facebook is a good start. And if you haven't yet signed on you owe it you yourself and to your church family to try it out.

But I'm also thinking of all the other ways we have to adapt our religious practice to these strange times. For instance, noticing when a friend of neighbor is being isolated because they are being careful to protect themselves and others. Loneliness is a real and dangerous reality for many these days. A phone call, a letter or a treat with a note


set on a doorstep can mean a great deal to a neighbor who hasn't seen anyone in several days.

There is no end to the possibilities our sanctified imaginations can find to be the inperson blessing God desires for the world God loves. We did continue to financially contribute donations to Community of Churches and Southwest WI CAP in Darlington food pantries. We supply paper products for fellowship hall, cards and postage for birthdays, anniversaries and get well/sympathy. Sunday school and Bible school expenses, Manor bingo, Lenten supper.
