# From the Interim Pastor February, 2021

#### Dear Friends,

One of the reasons I agreed to come to Darlington and serve as your interim pastor, was that I was intrigued by the problem of being the church, and being the pastor of a church, in the midst of a deadly, world-wide pandemic. I wanted to see if I could help a little with working that out. It turns out I was right about one thing—it is indeed a problem.

The things most of us love about church—a Sunday morning in the sanctuary, sunshine streaming through stained glass windows that tell the gospel story in pictures, and remind us of the faithful ancestors who installed those windows; drinking in the liturgy, the music, the bread and wine; sitting close to friends, complaining about noisy children, singing hymns of faith, shaking hands, giving hugs—all these things we love that have been our way of experiencing and expressing our faith have, for now, been taken from us.

Only, that's not exactly right, is it?

Nothing we love has been taken from us. The deeper truth, rather, is these things we love have been temporarily laid aside by us so that the people we love can be kept safe. We've made these hard decisions because we know in our hearts that what we most love about the church is not the church itself but the people we "do church" with. Not one of us, I'm quite sure, would ever choose the pleasure of a Sunday morning service over the health and well-being of anyone worshipping with us.

So seen in this light, foregoing one pleasure—Sunday mornings in our sanctuary, to preserve a greater pleasure—the company of those we love, really wasn't a difficult decision, or even a close call.

However, it is still a problem. Especially now as we are learning that it may be several months yet before enough of us are vaccinated and the Covid virus is knocked down far enough for us to safely gather again in the sanctuary on Sunday mornings. As the winter wears on we will be tempted to rush back inside. If neighboring churches decide to open their doors before we do, some will wonder why they can and we can't. There will be times when our resolve to love our neighbors more than we love our sanctuary will be tested. We need to be prepared for this test.

You should know your Church Council is paying close attention to pandemic developments. They are gathering the best information available from trustworthy

sources to guide their decisions on when and how to re-open for in-person worship, and they will be communicating their thinking to you on a regular basis. Expect to hear more very soon.

In the meantime, as we live through the coming months don't hesitate to call me or any of the Council members if you have questions or concerns. Our goal is to be as careful as is necessary and as transparent as possible with the sometimes very difficult decisions that lie ahead. We will continue to act out and act on Jesus's call to each of us to love our neighbors as we love ourselves.

Remember, we are all in this together and we will get through this together.

Christmas 2020

Dear Family and Friends,

No one needs to be reminded that 2020 has been a difficult year. But it's also true that life has gone on and where there is life there is the potential for joy and meaning. Ruby and I have experienced the same kinds of challenges and losses that others have, but it has also been a year of blessing and even unexpected gifts!

Before it was clear how deeply COVID-19 would impact life, we flew to Arizona in February to see family and friends, take in a couple spring training baseball games, hike in the desert and enjoy the warmth. It was a fun time!

Upon our return things rapidly changed. In-person worship at Zwingli UCC (where I'm pastor) was cancelled starting March 15 and hasn't yet resumed. Learning to care for a congregation using virtual worship and other technologies has been challenging. During the summer I decided that it was time to be retired for good and I submitted notice of my intention to be finished at the end of the year. That impending date provokes some real grief and sadness, but I am also firmly convinced that the decision is a good one. Still, I have come to love the people of Zwingli UCC and will miss them.

There were other adjustments to life brought on by the pandemic. Outings as mundane as trips to the grocery store took on an element of "adventure," and visits to other public venues came to a complete halt. We've spent a lot of time at home!

Ruby was especially occupied from Mid-March through mid-Judy with the care of her mother. With the onset of the pandemic, she and her sisters decided her 103-year-old Mom (Anne Schmid) might be safer if she stayed with us (where there are fewer folk coming and going) than where she had been. Mom is physically frail, so her care takes some work, but she is mostly alert and mostly easy to care for. In July she returned to the farm, and we again became "empty-nesters" — except, of course, for the dog!

But there have been things to do! In January we decided to purchase the empty lot to the west of our home. It's slowly been transformed from an unkept wilderness of ragweed and burdock to something a bit more civilized. Early in the pandemic son Paul and his family decided to return to the US from their work in Myanmar. After spending some time in Arizona, they traveled cross-country to Wisconsin (in a rented RV) in July, thinking they'd return to Myanmar in August. In fact, they were not able to return until mid-November. They rented a house half an hour from here, and we loaned them one of our cars and were able to spend much more time with Paul, Dawn and 8-year-old Piper than we've ever been able to do (including being with Piper on her birthday for the first time ever!). We had picnics and hiked at places like Devil's Lake State Park and canoed the Wisconsin River and more. It's been a delightful and unexpected gift!

In October, the three boys and their families with Ruby and me rented cabins at a church camp in far southwest Michigan near the Warren Dunes State Park on Lake Michigan and we enjoyed a family reunion of sorts. That's the only occasion we've had this calendar year to see Bob, Melissa and 6-year old Richie in person, and we had a great time!

Pete, Jenny and 12-year-old Kailey are nearby in Verona and we do get to see them — though not as frequently as in pre-pandemic days.

Another loss was a planned AMTRAK trip from Chicago to San Francisco to Seattle and then back to Chicago. There would have been stops along to way to see family and friends. I still hope to reschedule this trip — maybe later in 2021, but probably more realistically in 2022.

Ruby and I both enjoy retirement and find ways to make life meaningful even while mostly staying close to home. We miss the concerts and theatre in Madison. that were becoming a part of our lives. That loss is temporary. We look forward to getting our COVID vaccine shots when we're eligible and for the changes that will gradually occur once that happens.

In January we said goodbye to Quincy, our 13-year-old Cocker Spaniel. She was an oddly asocial creature, but we loved her and her death was a source of real grief. In the spring when we were confined to home, we decided to get new dog and we found a puppy who looks much like Quincy, but with a very different disposition. Maddie (short for Madison) is friendly and affectionate. She's pictured with granddaughter Piper in the far left of the enclosed photo (pictured during a hike at Picnic Point on the south shore of Lake Mendota for those of you who know the area). Kailey is pictured up in a tree at Tower Hill camp in Sawyer, Michigan during the family reunion I wrote of, and Richie is pictured on the shore of Lake Michigan during that same weekend. Like all grandparents we are profoundly proud of our grandchildren!

We miss you and look forward to the day we might visit and catch up on our respective lives!

#### What you need to know about the COVID 19 Vaccination

I understand that some people may be concerned about getting vaccinated now that COVID-19 vaccines are available. It is important for all of us to understand the facts about the

vaccination. The following information is directly from the CDC and I encourage you to take the time to read the information provided so that you can make the correct choice for you and the safety of others.

My experience with the vaccination has been good. I am proud to be one of the first to become vaccinated for you and me.

Can a COVID-19 vaccine make me sick with COVID-19? No. None of the authorized and recommended vaccinations approved contain the live virus that causes COVID-19. This means that a COVID-19 vaccine cannot make you sick with COVID-19. There are several different types of vaccines in development. All of them teach our immune systems how to recognize and fight the virus that causes COVID-19. Sometimes this process can cause symptoms, such as fever. These symptoms are normal and are a sign that the body is building protection against the virus that causes COVID-19. It typically takes a few weeks for the body to build immunity (protection against the virus that causes COVID-19) after vaccination. That means it's possible a person could be infected with the virus that causes COVID-19 just before or just after vaccination and still get sick. This is because the vaccine has not had enough time to provide protection.

After getting a COVID-19 vaccine, will I test positive for COVID-19 on a viral test?

No. Neither the recently authorized and recommended vaccines nor the other COVID-19 vaccines currently in clinical trials in the United States can cause you to test positive. If your body develops an immune response—the goal of vaccination—there is a

possibility you may test positive on some antibody tests. Antibody tests indicate you had a **previous infection** and that you may have some level of protection against the virus. Experts are currently looking at how COVID-19 vaccination may affect antibody testing results.

If I have already had COVID-19 and recovered, do I still need to get vaccinated with a COVID-19 vaccine? Yes. Due to the severe health risks associated with COVID-19 and the fact that re-infection with COVID-19 is possible, vaccine should be offered to you regardless of whether you already had COVID-19 infection. At this time, experts do not know how long someone is protected from getting sick again after recovering from COVID-19. The immunity someone gains from having an infection, called natural immunity, varies from person to person. Some early evidence suggests natural immunity may not last very long. We won't know how long immunity produced by vaccination lasts until we have more data on how well the vaccines work. Both natural immunity and vaccine-induced immunity are important aspects of COVID-19 that experts are trying to learn more about, and CDC will keep the public informed as new evidence becomes available.

Will a COVID-19 vaccination protect me from getting sick with COVID-19? Yes. COVID-19 vaccination works by teaching your immune system how to recognize and fight the virus that causes COVID-19, and this protects you from getting sick with COVID-19.

Will a COVID-19 vaccine alter my DNA? No. COVID-19 mRNA vaccines do not change or interact with your DNA in any way. Messenger RNA vaccines—also called mRNA vaccines—are the first COVID-19 vaccines authorized for use in the United States. mRNA vaccines teach our cells how to make a protein that triggers an immune response. The mRNA from a COVID-19 vaccine never enters the nucleus of the cell, which is where our DNA is kept. This means the mRNA cannot affect or interact with our DNA in any way. Instead, COVID-19 mRNA vaccines work with the body's natural defenses to safely develop immunity to disease. At the end of the process, our bodies have learned how to protect against future infection. That immune response and making antibodies is what protects us from getting infected if the real virus enters our bodies.

**Yes.** People who want to get pregnant in the future may receive the COVID-19 vaccine. Based on current knowledge, experts believe that COVID-19 vaccines are unlikely to pose a risk to a person trying to become pregnant in the short or long term. Scientists study every vaccine carefully for side effects immediately and for years afterward. The COVID-19 vaccines are being studied carefully now and will continue to be studied for many years, similar to other vaccines. The COVID-19 vaccine, like other vaccines, works by training our bodies to develop antibodies to fight against the virus that causes COVID-19, to prevent future illness. There is currently no evidence that antibodies formed from COVID-19 vaccination cause any problems with pregnancy, including the development of the placenta. In addition, there is no evidence suggesting that fertility problems are a side effect of ANY vaccine. People who are trying to become pregnant now or who plan to try in the future may receive the COVID-19 vaccine when it becomes available to them.

COVID-19 vaccination will be an important tool to help stop the pandemic.

- Wearing masks and social distancing help reduce your chance of being exposed to the virus or spreading it to others, but these measures are not enough. Vaccines will work with your immune system so it will be ready to fight the virus if you are exposed.
- The combination of getting vaccinated and following CDC's recommendations to protect yourself and others will offer the best protection from COVID-19.
- Stopping a pandemic requires using all the tools we have available. As experts learn
  more about how COVID-19 vaccination may help reduce spread of the disease in
  communities, CDC will continue to update the recommendations to protect communities
  using the latest science.
