#### **TAKING RISKS**

I present for your reflection and thought this piece on *Risks by Janet Rand*. I hope you find both encouragement and challenge as you reflect and you may find much more. I would love to have a conversation about it.

### Risks

To laugh is to risk appearing the fool.

To weep is to risk appearing sentimental.

To reach out for another is to risk involvement.

To expose feelings is to risk exposing your true self.

To place your ideas, your dreams, before a crowd is to risk their loss.

To love is to risk not being loved in return.

To live is to risk dying, to hope is to risk despair,

To try is to risk failure.

But risks must be taken, because the greatest hazard in life is to risk nothing.

The person who risks nothing, does nothing, had nothing, and is nothing.

They may avoid suffering and sorrow but if they cannot learn, feel, change, grow, love, live. Only a person who risks is free.

Many years ago, I came across this piece and reflecting on it helped me, affirm myself and encouraged me to be okay with the risks I took naturally- like laughing, weeping, reaching out, exposing feelings, sharing ideas freely, daring to dream big. I understand the risk that not everyone will agree with me or even like me. I also see the risks we are asked/called to take as we become more like Christ on our faith journey. Life is hard and there are many challenges and experiences that form us. The elements of this piece seem to give me, at least, a way to respond to hardships, people, and situations that call for a choice to move in one direction or the other. A choice that involves staying true to myself and the building of my character.

I take the risk of sharing this with you, I wonder what you think about it, how do you view it, how does it relate to you and your journey with Christ, what risks have you had to take? What risks will we as a church have to take to grow in these days?

### **CHURCH COUNCIL**

The September Church Council meeting was held on September 10, 2025.

Members Present: Phil Risseeuw, Kerry Black, Jordan Hinderman, Fritz Hirsbrunner, Sheila Siegler, Nancy Slama, Dave Sutherland, Connie Ubersox, Pastor Dana Caldwell, and Pam Hardt. Guest: Betsy Wiegel.

The Council approved the minutes from the last meeting as presented.

**Financial Report:** financial report for September was approved as presented.

**Pastors Report**. Dana is wondering about a cross placed between the two windows of the hallway between sanctuary and fellowship hall on the outside of the building. We will explore this more. Dana is settling in and unpacking. She will be making calls this next week on folks shut in.

**President's Report**. We have been approached to ring our church bell on Sept. 17<sup>th</sup> which is the day our constitution was signed. Phil advised the courthouse can ring their bell, we should not need to do this. Dana mentioned updating the church directory and how we could accomplish this. A notice will put in the October newsletter for folks to submit an updated picture if they choose to and update members and contact information. This is housed on ChurcTrac, Nancy and Sheila offered to help Dana with this update.

## Christian Education Committee- update given below.

Rally Day – September 14

Confirmation Update – confirmation will begin on Sunday, Sept. 14<sup>th</sup> at 9 am with 4 kids attending. Pastor Dana and Sheila will be leading the class.

### **Building & Grounds Committee -**

Steeple Repairs – The Council approved the steeple repairs at a cost of \$27,890.00 for the submitted repairs needed due to structural and outer defects.

**Mission Team** - Apple pie day is set for October 25<sup>th</sup>, shooting for 700 orders, \$12 each, try to get money up front for pies when taking orders.

**Stewardship Committee** - Sheila reports she and Pastor are attending a Stewardship Course online for 6 weeks, more to come.

**EF&G Committee** – nothing at this time.

**Endowment Committee - nothing at this time.** 

**Finance Committee** - Fritz gave update on Thrivent monies, excluding the endowment. The Council approved that anything requiring funds of \$5,000 or more be submitted with multiple quotes if feasible to the Finance Committee and they will review, approve and present to the Council. Discussed the church treasurers cash counting utilizing two financial secretaries, this has been working well. The Council approved the financial secretaries providing a copy of the cash verification form monthly to the Finance Committee.

Pastor-Parish Committee - meeting set up for Sept. 23<sup>rd</sup>.

**Search Committee** – will be removed from the agenda next month.

**Women's Guild** - meeting has been postponed until the 17<sup>th</sup>.

Worship Committee - nothing at this time.

### **Old Business**

Thrift Store Update – business plan changes were given to Council members. The plumber came to look at removing the two toilets and urinal, grant is almost ready to submit, Dana is working on a recommendation letter from the Council. Fritz suggested a

change to Article 4 of the business plan. Pam will make the changes. The Council is requesting the operational plan for the Thrift Store. We have this and will present to the Council at the October meeting. Pam will make an announcement on Sunday formally letting the congregation know about the Thrift Store and it's progress.

RBS Shirts – The Council reviewed 2 logos Pam had drawn up. The Council approved the logo #2 to be printed on shirts from RBS which church members can purchase on their own. A notice will be put in the October newsletter to congregants advising of the ability to purchase shirts.

Handicap Parking Spots Update – Dan Riley said they will get the parking spot locations fixed.

### **New Business**

Church Basement Windows – Estimate to replace them. We will get another bid. Sheila will reach out to Danny Lange. We will present at next council if possible.

Retired Communion Ware – What to do with it? The Council approved trying to see if we can find someone to donate this to. The Apple Grove church that was destroyed was suggested as a possibility.

The next Council meeting will be October 8th at 6:15 p.m.

In the letter to the Galatians, Paul encourages the church to "carry each other's burdens." This seems to be a clear enough encouragement. Why then, does he also say just a few verses later, "for each one should carry their own load?" This scripture highlights a dynamic many of us face when we help others or receive help. There's a difference between helping someone and taking over for them. Inversely, it can be both challenging and a source of comfort to receive care. Giving and receiving, with autonomy, is an integral part of justice ministries.

When the United Church of Christ gathers to collect the Neighbors in Need offering, we work to honor this complexity. The money collected supports the work of the UCC's Washington D.C. Office for Public Policy and Advocacy. The advocacy done in this office can be on behalf of churches, but most of the time, it involves partnership with congregations and church members across the nation. The work is shared through collective advocacy, with and for one another.

Contributing to this offering allows us to share one another's burdens. Two-thirds of your donation supports the UCC's justice and witness ministries, such as the D.C. Office. The remaining one-third supports the Council for American Indian Ministries (CAIM), which has been witnessing to Native values and culture as a vital part of the UCC since 1971.

This offering will be collected from September 21st - October 5th. Please look for more information in the bulletins and envelopes will be provided in the pews. Thank you for your gifts as we work together, sharing our burdens to support our Neighbors in Need.



As many of you know, our beautiful church steeple was struck by lightning during a mid-September thunderstorm. The exterior damage is visible from the street and we are thankful the damage was not more destructive.

Krause Konstruction of Coon Valley performed an on-site inspection of the damage and found there are additional repairs needed aside from the lightning strike damage. They found a beam that has moisture damage so it needs to be replaced, and are suggesting the spires and cross be scraped, repaired, and painted to help preserve the structure and prevent further water damage to the interior.

Krause prepared two bids, one for repairing the lightning strike damage and the other for repairing the beam, spires, and cross. Immanuel's insurance company agreed to cover 100% of the cost of the repairs related to the lightning strike and for that, we are very grateful. But IUCC needs to cover the cost of replacing the beam and the repair of the spires and cross, and those repairs will cost \$27,890. While Immanuel has Memorial Funds to cover this expense, we are asking for donations specifically for this repair work.

Would you consider giving an additional amount to help preserve our beautiful steeple, spires, and cross? Donations can be made via mail, ACH or credit card via ChurchTrac, or during Sunday worship offering time. Please mark your contribution as 'Steeple'.

We greatly appreciate any donations that can be made to contribute towards the valuable repairs.

# Immanuel's 2025 Financial Update - Q&A

As many of you know, this year has been one of significant financial activity for Immanuel. We've received a generous bequest, undertaken repairs to our beautiful stained-glass windows, and faced unexpected damage to the steeple after a lightning strike. Below, you'll find a brief Q&A with updates on these important matters. Please feel free to reach out to a Council member or Finance Committee member (Fritz, Phil, or Betsy) with additional questions or concerns.

# Q. How much money did we receive from the Blankenhorn estate, and have we received all of the money we were bequeathed?

A. We are very blessed and grateful that Sylvia Blankenhorn named Immanuel as a beneficiary in her Will. Sylvia put our church in her trust in memory of her parents, Richard and Anna Blankenhorn, and uncle, John Thomann who were charter members of the church. We received

a total of \$529,046 from Sylvia's estate and the estate is considered settled. Of that amount, \$522,056 was placed in the Memorial Fund account at Thrivent. The balance was placed in the General Fund.

### Q. How much has been paid towards the windows?

A. We have paid the required 25% down payment in the amount of \$73,504. These payments were made from the General Fund which had excess funds at the time of payment. The next installment of 25% will be due upon commencement which is expected to be before the end of the year. The final 50% is due upon completion which is estimated to occur in late 2026. A total of \$220,512 is yet to be paid and those payments will be made from the Memorial Fund.

### Q. What about the steeple?

A. The steeple has two different types of damage. There is damage from the lightning strike that will cost \$60,280 to repair and Immanuel's insurance is paying 100% of those costs. There is also age and moisture related damage. There is a main beam that is rotting and the spires and cross need to be repaired and maintained to preserve them as well as the steeple structure itself. The non-lightning strike repairs will cost \$27,890.

# Q. Why are we doing the other repairs for \$27,890 now?

A. A portion of these repairs, such as replacing the beam, are necessary to give the construction crew a solid foundation upon which to repair the area affected by the lightning strike. These repairs could be delayed for the time-being, but that would put our steeple at risk of imploding at some point in the future. And then it would cost even more to make the repairs. It is to our benefit to take advantage of the construction crew being on-site to make all necessary repairs at once.

# Q. Was there a company that could do this for less money or is there a local contractor that could be used?

A. Steeple repair, as you can imagine, is a specialized skill and service and also requires the appropriate equipment. Krause Konstruction is known in the western part of Wisconsin as one of the best companies. We could have explored companies in eastern Wisconsin, but that would have taken more time, would probably be more expensive, and Krause comes to us with solid references.

### Q. When will the steeple be fully repaired?

A. Krause Konstruction was available this week (9/17) to wrap our steeple to prevent further water damage. They expect to return in the near future to start the repairs.

### Q. How are we paying for the \$27,860 of additional repairs?

A. Immanuel certainly has funds available in the Memorial Fund to pay for these repairs. But we are asking members and non-members to consider making contributions towards this project.

# Q. Why are we being asked to make extra contributions, if there is already money to cover the cost?

A. Immanuel has been truly blessed with two generous bequests over the last 10 to 15 years. However, looking ahead, there are some other major expenses on the horizon. Immanuel has aging HVAC equipment and we are anticipating a mandatory roof repair on the Fellowship Hall, along with window replacements in the Church basement. In total, we expect these costs, along with other potential future needs, to exceed \$100,000.00 over the next 15-20 years. In light of this, we are asking members to prayerfully consider making a special contribution toward the steeple project. Please note, this contribution is entirely optional.
