ORDER OF BUSINESS

Meeting was called to order at 10:43 a.m. by Vice-President Roy Berrey

Opening Prayer and Memorials: Opening Prayer was given by Roy Berrey. Roy read the names In Memoriam: Janice Schadewalt, John (Dave) Ubersox and Mary Lindell.

Approval of Minutes of the January 31, 2021 Annual Meeting. Motion made by Bernie Ruf to approve the Minutes from the January 31, 2021 Annual Meeting. Seconded by Jean Stauffacher. Motion Approved.

Financial Report/Consideration of 2022 Budget

Bernie Ruf asked for an explanation as to why there was \$54,789 in "Transfers" under the "Actual 2021" column of the Budget. Betsy Wiegel explained that there were 2 or 3 CDs for the General Fund that came to maturity and were the deposited into the General Fund.

Marjean Sutherland made a motion to approve the above reports as presented. Second by Fritz Hirsbrunner. Motion Approved.

Auditor's Report

Jean Stauffacher made a motion to approve the Auditor's Report as presented. Second by Rodney Lindell. Motion Approved.

OLD BUSINESS

- 1. Strategic Planning Committee Update The committee's priority in deciding whether to have in-person worship services vs worship services via Zoom during COVID was the safety of the congregation. We are happy the services are back to in-person. Immanuel also has a Pulpit Pastor by the name of Bill Whitford who will be taking over services when Pastor Brad Brookins leaves. Bill will start March 6, 2022 at Immanuel and will be here until we get a new pastor.
- Search Committee Update Marjean Sutherland reported that the Search Committee has received 5 more profiles to review – no interviews are scheduled.

NEW BUSINESS

- 1. By-Laws Changes Fritz Hirsbrunner led the discussion on the By-Laws changes. Fritz informed the Congregation that the Strategic Planning Committee, which consisted of Janette Steger, Kate Black and Fritz, reviewed the By-Laws. Bernie Ruf pointed out there is a sentence in Article VIII Church Council, 1 Membership that states that "The terms of the elected by the Congregation members shall be arranged in classes of four, such that each year one class shall be elected." This was written when there were 12 members on the Church Council. This was discussed and it was decided to take that sentence out of the By-Laws. Betsy Wiegel mentioned that there should be a distinction between the Administrative Secretary vs the Council Secretary. Fritz Hirsbrunner made the distinction that the Administrative Secretary keeps the membership records and the Council Secretary does everything else according to the By-Laws. Fritz Hirsbrunner made the motion that the By-Laws changes be approved as presented with these two changes. Second by Kerry Black. Motion approved.
- Report of Nominating Committee and Election The Council Members nominated for election are Kerry Black, Nancy Slama, and Roy Berrey for his 2nd term. The Endowment Fund members nominated for election are Karl (Fritz) Hirsbrunner and Connie Ubersox. Roy Berrey thanked Roy Hardt and Matt Ubersox for their

service on the Council and Kerry Black and Ann Reuter for their service on the Endowment Fund Committee.
Ron Johnson made the motion to elect Kerry Black, Nancy Slama and Roy Berrey to the Church Council, and to elect Fritz Hirsbrunner and Connie Ubersox to the Endowment Fund. Second by Randy Ubersox. Motion approved.

3. Investments - There was discussion regarding the CDs designated for the General Fund and the Memorial Fund. There are two Memorial Fund CDs coming due. Roy Berrey and Kerry Black spoke on a presentation they attended from the UCC Foundation. The UCC Foundation would assist Immanuel with our investments. The Council wanted guidance on what the congregation would like them to do and asked the congregation to make recommendations as to where to put our money--in safe investments or some money in risky investments to make more money. Immanuel would always be able to take money out as needed. There was discussion on how to proceed. Fritz Hirsbrunner made the motion to authorize the Council to invest excess funds in the General and Memorial accounts as in their judgment and discretion as they deem wise and prudent. Second by Orvin Siegenthaler. Motion approved.

Orvin Siegenthaler brought up that the church should use some of its money to remodel the kitchen and bathroom parsonage before we find a new pastor. The parsonage is 70 years old and needs some updating. Orvin mentioned that Mrs. Steiner left money to the church and it could be used for the remodeling. Roy Berrey mentioned that the Buildings & Grounds Committee has been looking into this.

Roy Berrey gave the closing prayer.

Fritz Hirsbrunner made a motion to adjourn the meeting. Second by Tana Risseeuw. Motion approved. The Annual Meeting was concluded at 11:15 a.m.



2022 Annual Report of the Conference Minister Wisconsin Conference United Church of Christ

"Arise, shine, for your light has come, and the glory of the Lord has risen upon you." Isaiah 60:1

I greet you in the spirit of Epiphany, a season that brings light into the darkness and incarnates love into a broken and fragile world.



Every day, the mission and ministry of our wider United Church of Christ affects lives near and far. Together, our spiritual values and inclusive theology, our mission dollars and commitment to justice make a real difference in this world. Spiritually progressive people resonate and partner with us!

In practice, the daily task of the Wisconsin Conference is to **connect, resource and support** local churches, pastors and leaders. In 2022, keeping pulpits filled was a real challenge. Fortunately, the Conference continued to attract pastoral candidates from around the country as the Conference staff worked tirelessly to support more than 50 searches. Conference programs thrived, including **Supportive Ministries, Conflict Transformation Team, Unified MID Team** for Members in Discernment, **Damascus Project** and **Catalyst Grants**, which helps congregations build partnerships in their local communities to serve the common good. Project grants totaled \$31,794 in 2022.

Our justice work continues. The Creation Care Team is engaging congregations in the *Kairos Call to Action*. The WISE movement -- Welcoming, Inclusive, Supportive and Engaged for mental health -- is gaining traction. We are rolling out a new anti-racism training curriculum through the Damascus Project and continuing our efforts toward Indigenous justice with the Ho Chunk Nation.

The Daycholah Center at Green Lake will soon become our new Conference headquarters. Later in January, the Conference will close on a \$2.4 million agreement with United Church Camps Inc. to transfer the Daycholah Center deed to the Conference, thereby alleviating much of UCCI's debt and allowing for a robust multiyear reboot of our Outdoor Ministries. We now have an accepted purchase offer for the Conference office in DeForest, with plans in place to convert it to a Holistic Health Clinic. We expect that the office transition to Daycholah will take place by early spring, although most staff work will continue to be done remotely.

The Conference board of directors is deeply grateful for your congregation's commitment to Our Church's Wider Mission, and we continue to grow the Wisconsin Foundation UCC, which now manages the assets of several congregations. We invite you to explore this option for your church. We also launched the Leadership Forward capital campaign focusing on long-term funding for three essential Conference ministries: Damascus Project, Catalyst Grants and Ministerial Assistance.

Finally, 2022 brought several significant staffing transitions. In September, we welcomed the **Rev. Rachel Bauman** as the new associate conference minister in the Southern region. In January, we are excited to welcome the **Rev. Michael Jones** as the next associate conference minister in the Northwest, succeeding the retired Rev. Rob MacDougall. We also hired an excellent new part-time annual meeting planner, **Jaime Craig**, and are thrilled to announce (along with the Minnesota Conference) the calling of a new Damascus Project director, the **Rev. Stephanie Perdew**.



UCC Foundation Investments Report (Memorial Fund)

All Memorial Funds were moved from the First National Bank Money Market account to the United Church of Christ Investment Foundation.

Freida Steiner Baxter CD matured in April of 2022 with proceeds of \$31,620.83.
